Proceduren for udlevering af indleveret gods som er bestemt for udførsel ud af EU, ændres pr den 1. december 2015.

Der skal ikke længere oprettes en MIO (status 40) eller FUE (status 40) på det indleverede gods for at det kan udleveres igen (har kun været gældende for X-gods).

Der kan både være tale om gods indleveret med en udførselsangivelse (X-gods = T2-gods = varer i fri omsætning i EU) eller uden udførsel (C-gods = værdi under 7.500,- kr – samme Grønland og Færøerne).

Speditøren skal anmode Toldekspeditionen – Told 16 på Kystvejen på mail: Toldekspedition.Kystvejen@skat.dk om det indleverede gods (Udførslens MRN-nr skal oplyses) kan udleveres. Udførslen kan enten anmodes slettet samtidig eller anvendes samme dag hos en anden Handler i Københavns Lufthavn. Told 16 vil herefter give svar retur til Speditøren.

Before this export shipment will and can be released, we would need that mail as documentation.
